//ORDER//

Miss Nguncha Tangjang is hereby engaged as J/T on contractual basis and posted to Govt Secondary School Kapu under Tirap District in the fixed pay of Rs. 26453/- (Rupees twenty six thousand four hundred fifty three) only with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions:-

1. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No Earned leave is permissible except casual as per Central Civil Leave Rule and as per terms and condition mentioned in the copy.
3. During contract service period he /she is not entitle for medical reimbursement, winter allowances, children educational allowance reimbursement of tuition fees, leave travel concession (LTC) Special compensatory allowances etc.
4. The Second party shall be entitle for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge course and any other departmental engagement.
5. The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as cancelled.
6. He/She is not entitle to subscribed GPL or CGEIS of such order schemed during the period of contract service.
7. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.
8. He /She will have to undergo DIET training at concern DIET for training as and when call for.
9. The order terms and condition of the service which are not specified shall be governed by the relevant rules and order forced time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
