ORDER

In pursuance of Government Approval Vide U.O.No 188 dated 20.07.2007, Smti Nita Devi Sharma is hereby appointed temporarily to officiate as Assistant Teacher(A) on compassionate ground in the Scale of Pay of Rs. 4500-125-7000/- p.m plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the Deputy Director of School Education, Bomdila, West Kameng District, Arunachal Pradesh. She is posted at Govt. Secondary School, Bhalukpong, West Kameng District.

2. The appointment is made on compassionate ground as per the Government of India, Ministry of Home Affairs Order No 14014/20/90 Estt (D) Dated 09/12/1993. The appointment is made against Shri M.S.Dua AT(A) Retired.

3. The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining. His/Her continuation in service beyond probation for 2(two) years is subject to satisfactory performance during probation period.

4. The appointment is subject to the following conditions:-

(a) The appointment is purely temporary and may be terminated with 1(one) month notice. If He/She wants to resign he/she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.

(b) The regularization of service may be considered on completion of probationary period subject to satisfactory performance of duty.

(c) After joining duty he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.

(d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.

(e) The appointment is subject to the Police Verification and he/she will be dismissed from Government service if any adverse report is there with immediate effect.

(f) The Educational Qualification is temporarily relaxed for 2(two) years. The appointee shall have to be acquired B Ed. qualification within 2(two) years from the date of issue of this order.

Other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
