## ORDER

  - 4 The appointment is subject to the following conditions -
  - (a) The appointment is purely temporary and may be terminated with 1(one) month notice. If He/She wants to resign he/she may do so efter giving 1(one) month notice or by surrendering 1(one) month salary.
  - (b) The regularization of service may be considered on completion of probationary period subject to satisfactory performance of duty.
  - (c) After pining duty he'she will have to take an nath of elegiance of affirmation to the Constitution of India in the prescribed faim
  - (c) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer
  - (e) The appointment is subject to the Police Verification and he/she will be dismissed from Government service if any adverse report is there with immediate effect.
  - (f) The Educational Qualification is temporarily relaxed for 2(two) years. The appointee shall have to be acquired B.Ed. qualification within 2(two) years from the date of issue of this order.

Other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
