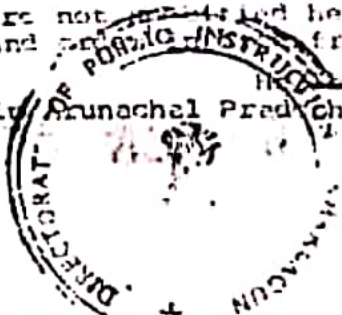
2. The officer shall be on probation for a period of 2 (two) years with effect from the date of joining. His/~~her~~ continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one months notice. If he/~~she~~ wants to resign may require to give one months notice or surrender one months salary.
- (b) After joining in the duty he/~~she~~ shall have to take oath of allegiance of affirmation to the constitution of India in the prescribed form.
- (c) He/~~she~~ will have to produce medical fitness Certificate in prescribed form from an authorised medical Officer.
- (d) The appointment is subject to Police Verification and he/~~she~~ will be dismissed from Govt. Service if any adverse reports are there with immediate effect.

4. The other terms and conditions of Service which are not mentioned herein shall be governed by the relevant rules and regulations from time to time.

5. He/~~she~~ will be transferred to Schools anywhere in Arunachal Pradesh.
