ORDER

In pursuance of Govt. approval vide U.O. - b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect
