The engagement is subject to the following conditions:-

- a. The contract teacher has not right to claim for regular appointment / regularization of the post after expury of contract engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period he/ she is not entitled for Medical Reinbursement; Winter allowance; children educational allowance; reimbursement of tution fees; leave travel concession (LTC); special compensatory allowance etc.
- d. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. He/ she is not entitled to sposcribe GPR or CGEIS or such other schemes
- f. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Aranachal Pradesh in addition to his / her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/She will have to undergo DIET training at the concerned DIET for training as and when called for.

- i. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- i. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
