Shri/ Smti/Miss Pema Waneben Shongla is hereby engaged as Primary Teacher (AT) on contract basis in the fixed pay of Rs. 21175/- (Rupees Twenty One Thousand One Hundred Seventy Five) only with effect from the date of joining in the concerned school. He/ She will have to join within one week from the date of issue of this order against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/ She is posted at Govt. Primary School Amshingthang.

The engagement is subject to the following conditions:-

- a. The contract period is for a period of one year commencing from the date of joining in the school and ending at 31st March of the financial year.
- b. For extension of the contract period, the contract teacher shall sign a deed of agreement at the end of the financial year which shall be based on the performance report submitted by the concerned Chairperson of the School Management Committee countersigned by respective Block Education Officer.
- c. The contract teacher has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- d. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- e. During contract service period he/ she is not entitled for Medical Reimbursement; Winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- f. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- g. He/ she is not entitled to subscribe GPI or CGEIS or such other schemes during the period of contract service.
- h. No representation will be accepted for change of posting place.
- i. He/She will have to undergo any departmental training as and when called for.
