//ORDER//

Miss Reagle Socia is hereby engaged as AT (SSA) on contractual basis and posted to Government Middle School, Naithong under Tirap District in a fixed pay of Rs. 21,175 /- (Rupees twenty one thousand one hundred seventy five) only with effect from the date of joining in the concern district up to the academic session against centrally sponsored scheme of Sarva Siksha Abhiyan (SSA).

The engagement is subject to the following conditions:-

- 1. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract agreement.
- 2. No earn leave is permissible except casual leave as per central civil leave rule and as per terms and conditions mention in the copy.
- During contract service period he /she in not entitled for medical reimbursement, winter allowance, children education allowance, reimbursement of tuition fee, leave travel concession, special compensatory allowance etc.
- 4. The second party shall be entitled for drawl salary of only academic session. Salaries for vacation period shall be drawn only when they are engaged and training, bridge course and any other departmental engagement.
- The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concern DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- 6. He/she is not entitled to subscribe GPF or CGEIS of such order scheme during the period of contract service.
- 7. The engaged teacher is also to work as volunteer/ instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- 8. He/she will have to undergo DIET training at concern DIET for training as and when call for.
- 9. The order terms and condition of the service which are not specified shall be governed by the relevant rules and order forced time to time.
- 10. The engaged teacher has to sign and an Agreements for contract engagement before receiving this engagement order.
