ORDER

Miss Debia Jirnia is hereby engaged as J/T on contract basis in the fixed pay of Rs 8500/- (Rupees Eight Thousands Five Hundreds) only against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. She is posted at Govt. Middle School, 'D' Sector, Itanagar under Itanagar Circle.

The engagement is subject to the following conditions: -

- a) The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned EAC, failing which her engagement order will automatically be treated as cancelled.
- e) She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f) The engaged teacher is also to work as volunteer instructor for TLC Programme for the interest of the literacy in Arunachal Pradesh in addition her normal duties.
- g) No representation will be accepted for change of posting place.
- h) She will have to undergo DIET training at concerned DIET for training as and when call for.
- i) The validity of contract periods is up to 31/3/2008, which may be extended by seeing the performance/ regularity of teacher as recommended by the concern V.E.C.
- j) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in force at the time.


