- h) No representation will be accepted for change of posting place.
- i) He / she will have to under gone DIET training at concern DIET for Training as and when call for
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
