## ORDER

Shri Janibey Tsering is heraby appointed as A/T on contractual backs against the resultant vacancy created by the resignation of Shri Nima Tsering, A/T, Govt. Upper Primary School Dudungkhar, under Tawang district in the fixed pay of Rs. 10800/- (Rupees Ten Thousand Eight Hundred only) with effect from the date of joining in the concerned district against centrally sponsored scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions:-

- a) The contractual teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and conditions mentioned in the agreement copy.
- c) During Contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession(LTC); Special compensatory allowances etc.
- d) The Second party shall be entitled for drawal of salary only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e) The contract teacher has to report his/her duty at posting place within 7(seven) days from the date of joining in the office of concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representations will be accepted for change of posting place.
- i) He/she will have to undergo DIET Training at concerned DIET for training as and when called for
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving order.
