

ORDER

In pursuance of Govt. approval vide U.O. No. Dated 03/03/2008 the service of Shri/Smti/Miss Benjamin Boko is hereby regularized temporarily to officiate as Assistant Teacher(A) in the Scale of Pay of Rs.4500-125-7000 p.m. plus other allowances as admissible under Rules from time-to-time w.e.f. he/she actually reports for duty to the DDSE, Yingklong, Upper Siang District, Arunachal Pradesh. - d) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect
