Plus other allowances as admissible under the rule from time to time with effect from the date on which he/she reports for duty to the DDPI Office Papum Pare Dist. Naharlagun.

1. The appointment is subject to the following conditions:-
  - a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month Notice from either side.
  - b) After joining duty he/she will have to take an oath of allegiance of giving affirmation to the constitution of India duly in the prescribed form.
  - c) He/She will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is Medically fit for the Govt. Service.

The appointment is subject to the Verification of his/her character and antecedents and he/she will be discharged from Service with immediate effect if there be any adverse remark against him in the verification report.

3. He/She will have to serve in the interior most School for at least 3 (Three) years without any representation.
