## ORDER.

(d) The appointment is subject to Police Verification and she will be dismissed from service if any adverse report is found against his with immediate effect.

(e) After joining duty he will have to take an oath of allegiance of affirmation to the constitution of India in the prescribed form.

(f) On joining the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.

(g) The seniority of the appointee will be based strictly on merit list.

(h) The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting or does not join within 10 (ten) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
