- The seniority of the appointee shall be based strictly on merit list. (g)
- The appointment order shall be cancelled if the appointee directly or indirectly (h) campaign for change of posting place or does not join within 15 (Fifteen) days from the date of issue of this order at posting place..
- (i) On their appointment as Assistant Teacher they should undergo compulsory in-service DPE/B.Ed. within 3 (Three) years failing which their appointment order shall be canceled in the light of RTE Act.
