2. The appointment is made against the vacant post of PTI

3. The officer shall be on probation for a period of 2 (two) years with effect from the date of joining. His/Her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

4. The appointment is subject to the following conditions:-

- The appointment is purely temporary and may be terminated at any time without assigning any reasons. If he/she wants to resign he/she may do so after giving one month's notice or by surrendering one month pay.
- After joining the duty he/she shall have to take on Oath of allegiance of affirmation to the constitutions of India in the prescribed form.
- He/She will have to produce Medical Fitness Certificate in prescribed form from an authorized Medical Officer.
- The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- The other terms and condition of services which are not specified herein, shall be governed by the relevant rules and order's in force from time to time.

5. Shri/Smti Mangam Karbak shall have to continue for a minimum tenure of 3 (three) years terms in his/her present posting place.
