ORDER

Shri OM Prakash Choubey is hereby appointed to officiate as Junior teacher(ZBC) in the Scale of Pay of N. 1400-40-1600-50-2300-EB-60-2600/-P.M. plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the Deputy Director of Public Instruction, Tezu, Lohit District, Arunachal Pradesh under the Scheme of Operation Block Board.

2. Shri OM Prakash Choubey has been posted to Inje Primary School, Lohit District(Wakro Block).

3. The Officer shall be on probation for a period of 2(two) years with effect from the date of joining. His continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

4. The appointment is subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one months notice. If he wants to resign may require to give one months notice or surrender one months salary.
- (b) After joining in the duty he shall have to take an oath of allegiance of affirmation to the constitution of India in the prescribed form.
- (c) He will have to produce medical fitness certificate in prescribed form from an authorised medical Officer.
- (d) The appointment is subject to Police Verification and he will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- (e) The appointment is made temporarily subject to Verification of his Educational Qualifications from the concerned University.

5. The Other terms and conditions of Service which are not specified herein shall be governed by the relevant rules and order in force from time to time.

6. He will be transferred to Schools any-where in Arunachal Pradesh.

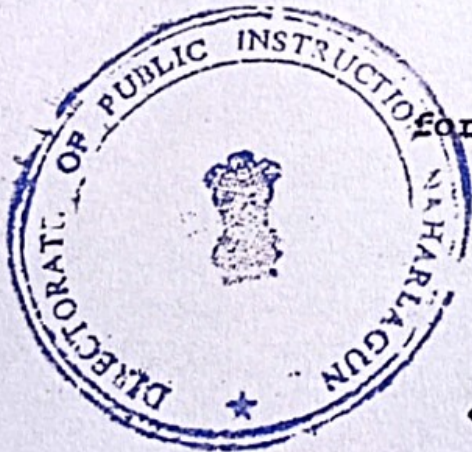


