**ORDER**

Shri Sange Lama is hereby engaged as Junior Teacher (on contract basis) in the fixed pay of Rs. 26,450/- (Rupees Twenty Six thousand four hundred fifty three only) with effect from the date of joining in the concerned district up to 31<sup>st</sup> March 2016 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is posted at Govt. Primary School Tsolingpan under Kalakting block.

The engagement is subject to the following conditions:

- a. The contract teacher has not right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period, he/she is not entitled for Medical Reimbursement, Winter allowance, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
- d. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. He/she is not entitled to subscribe GPF or CGES or such other schemes during the period of contract service.
- f. The engaged teacher is also to work as volunteer instructor for TLE programme for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/She will have to undergo DIET training at the concerned DIET for training as and when called for.
- i. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
- j. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k. Joining shall be accepted from the 1<sup>st</sup> June 2015 on opening of new academic session upto 7<sup>th</sup> June 2015 failing which order shall be treated as cancelled.
