ORDER

Shri Tabu Ita is hereby appointed as Part Time Instructor (Work Education) on contractual basis with salary of ₹ 12,800/- (Rupees Twelve Thousand Eight Hundred only) only with effect from the date of joining at the concerned School up to 31/03/2016 against Centrally Sponsored Scheme of SSA. He/She is posted at Govt. Upper Pry. School, Khamlee

The appointment is subject to the following conditions:-

- (i) Contractual staff has no right to claim for regular appointment/regularisation of the post after expiry of contract period
- (ii) He/She will be liable for casual leave as per Central Civil Service Leave Rule and other rules mentioned in the agreement copy.
- (iii) During contract period he/she is not entitled for medical reimbursement, winter allowance, educational allowance, reimbursement of tuition fees, leave travel concession, gratuity, provident fund allowance etc.
- (iv) The contract staff has to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned school headmaster, failing which his/her appointment order will automatically be treated as cancelled.
- (v) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- (vi) No representation will be accepted for change of posting place.
- (vii) The contract period ends on 31/03/2016 which may be extended by issuing fresh orders on account of extraordinary demand of salary complement for contract staff.
- (viii) He appointed staff has to sign an agreement for contract engagement before receiving the appointment order.
- (ix) The staff will be released at school level only after receipt of fund from the Govt. of Arunachal Pradesh, Itanagar.
- (x) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other orders from time to time.
