- c) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession or D.T. Special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f) No representation will be accepted for change of posting place.
- g) He/She will have to undergo DIT training at concerned DIT for training as and when call for.
- h) The validity of contract period is upto 31-03-2011 which may be extended by seeing the performance, regularity of teacher as recommended by concern A.T.C.
- i) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in force time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k) The Salary will be released only after receipt of fund from Govt. of India.
