ORDER

Shri Yarda Duri is hereby engaged as *Primary Teacher (PRT)* on contract basis in the fixed pay of ₹21,175.00 (*Rupees Twenty One Thousands One Hundred Seventy Five*) only with effect from 01/06/2017 to 31/03/2019 against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. He/She is posted at *DPO Office, Yupia*.

The engagement is made vide resignation / expire/waiting panel/not joined of Shri/Smt. TGT / PRT (SSA) (Application in case of resultant vacancies)

The engagement is subject to the following conditions: -

- The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.
- He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- No representation will be accepted for change of posting place.
- He/She will have under go DIET training at concerned DIET for training as and when call for.
- The validity of contract period is upto 31/03/2019 which may be extended by seeing the performance/ regularity of teacher as recommended by concern SMC.
- The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- The salary will be released only after receipt of fund from Govt. of India.
