

//APPOINTMENT ORDER//

Miss. Sitnyam Bangyang is hereby appointed as PRT Elementary on contract basis in the fixed pay of Rs. 15,000/- p.m. (Rupees Fifteen Thousand) in vacancy against Shri Starley Nabam due to resignation, only with effect from the date of Joining in the Concern School upto 31/03/2022 for 1 (one) year against centrally sponsored Scheme of Samagra Shiksha - An Integrated Scheme for School Education and Posted to Govt. Middle School Nyokum Lapang Itanagar.

The appointment is subject to the terms and condition of Contract signed between the District Project Officer, on behalf of State Project Director ISSE, Samagra Shiksha Itanagar and the Appointee. The tenure of service will be counted from the date of Joining in the concern school.

The engagement is subject to the following conditions:-

- a. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditioned in the agreement copy.
- c. During contract service period he/she is not entitle for medical reimbursement; winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d. The contract teachers have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- f. The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/she will have to undergo DIET training at concern DIET for training as and when call.
- i. The other terms and condition of service which are not specified shall be governed by the relevant rules and order in forced time to time.
- j. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
