ORDER

Shri Hem Tamara is hereby engaged as A/T on contract basis with the pay of Rs. 7000/- (Rupees seven thousand two hundred) only with effect from 01.10.06 with an effect for the concerned subject upto 31.03.2007 against Centrally Sponsored Scheme of SSA vide order No. A/100/2005/7620. He is posted at Primary Upper Primary School, [unclear].

The engagement is made after verification of existing professional record of Shri. [unclear] A/T (SSA) (Application in case of [unclear]).

The engagement is subject to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment or regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service (CCA) Rules and as per terms and conditions mentioned in the agreement copy.
- c) The contract teacher's period of absence is not entitled for medical certificate, study allowances, children educational allowance, dearness allowance, gratuity, travel concession (TTC), Special Allowance, etc.
- d) The contract teacher has to report to his/her duty at posting place within 7 days after receipt of the order of appointment in the office of the concerned DPO. A copy of the contract engagement order will automatically be created as intimated.
- e) The contract teacher is not eligible for CDS or any other schemes during the period of contract.
- f) The contract teacher is also to work as volunteer instructor for A.T. programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No compensation will be accepted for change of posting place.
- h) The teacher will have to undergo DIT training at concerned DIT for minimum 3 months when called for.
- i) All other terms and conditions of service which are not specified shall be governed by the relevant rules and orders in force from time to time.
- j) The contract teacher has to sign an agreement for contract engagement before the date of commencement of work.
