**ORDER**

Miss Nani Yaza is hereby appointed as J/T on contract basis in the fixed pay of Rs. 8500/- (Rupees Eight thousand and five hundred) only with effect from the date of joining in the concerned district for a period of 1 (one) years against centrally sponsored scheme of Sarva Shiksha Abhiyan. He/She is posted to Hill Top Middle School.

The appointment is subject to the following:-

1. The contract appointee has not right to claim for regular appointment/regularization of the post after expiry of contract appointment.
2. No earned leave is permissible except casual leave as per Central Civil Service leave Rule as per terms and condition mentioned in the agreement copy.
3. During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition on fees, leave travel concession (LTC), special compensatory allowance etc.
4. The contract appointee have to report his/her duty at posting place within 7(seven) days from the joining in the concerned DDSE failing which his/her appointment order will automatically be treated as canceled.
5. He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
6. The appointed teacher is also to work as volunteer instructor for TLC Programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. He/She will have to under gone DIET training at Naharlagun when call for DIET training at Naharlagun.
9. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
10. The appointee teacher has to sign and agreement for contract appointment before receiving this appointment order.
