ORDER

Smti Tokio Rimi is hereby engaged as A/T (Assistant Teacher) on contract basis in the fixed pay of Rs.7200.00 (Rupees Seven Thousand Two Hundred) only with effect from the date of joining in the DDSE office, Ziro Lower Subansiri District against centrally sponsored scheme of Sarva Shiksha. He/ She is posted at Govt. Primary School, Yajali C-sector (Ziro - II).

The engagement is subject to the following condition.

- (a) The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of the contract engagement.
- (b) No. Earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- (c) During contract service period he is not entitle for medical reimbursement; winter allowances; children education allowances, reimbursement of tuition fees leave travel concession (LTC), special compensatory allowances etc.
- (d) The contract teacher before joining to his posting place on 1st June'06 will have to undergo induction training for 20 days at DIET Papum Pare, Naharlagun and the date of the training shall be intimated shortly after confirming from the Principal DIET, Naharlagun. No Teacher will be allowed to join his/her posting place without having the induction training.
- (e) He/She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- (f) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- (g) No representation will be accepted for change of posting place.
- (h) He/ She will have to undergone DIET training at concern DIET for training as and when call for.
- (i) The other terms and conditions of services which are not specified shall be Governed by the relevant rules and order in forced time to time
- (j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
