**ORDER**

- f) He/She is not entitled to subscribed GPF or CGEIS or such other scheme during the period of contract service.

- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


