ORDER

Miss Tana Limi is hereby engaged as *Trained Graduate Teacher (TGT)* on contract basis in the fixed pay of **₹.26,453.00 (Rupees Twenty Six Thousands Four Hundred Fifty Three) only** with effect from 01/06/2017 to 31/03/2018 against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. He/She is posted at **Govt. Upper Pry. School, Amba**.

The engagement has been made prior approval from State Project Director, SSA Rajya Mission, Itanagar vide approval Order No AR/SSA/Inter-APTET-17/2017-18/ Dated Yupia the 18th Sept'2018

The engagement is subject to the following conditions: -

- a) The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f) No representation will be accepted for change of posting place.
- g) He/She will have under go DIET training at concerned DIET for training as and when call for.
- h) The validity of contract period is upto 31/03/2018 which may be extended by seeing the performance/ regularity of teacher as recommended by concern SMC.
- i) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k) The salary will be released only after receipt of fund from Govt. of India.
