- e. He/ she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of Literacy of Arunachal Pradesh addition to his/her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/ she will have to undergo DIET training at concern DIET for training as and when call.
- The other terms and condition of service which are not specified shall be governed by the relevant rules and order in force from time to time.
- j. The engaged incumbent has to sign an agreement for contract engagement before receiving this engagement order.
