

//APPOINTMENT ORDER//

Shri. Dishi Tadi is hereby appointed as PRT (ISSE) Elementary on contract basis in the fixed monthly pay of Rs. 15,000/- (Rupees fifteen thousand) only/- with effect from the date of joining in the concern school up to 31/03/2023. The appointment is made against the resultant vacant post of PRT (ISSE) due to the resignation of Ms. Asum Putum, PRT (ISSE) under centrally sponsored scheme of Samagra Shiksha – An Integrated Scheme for School education and posted at Govt. Primary School Donyi Dokum, Colony, Itanagar.

The appointment is subject to the terms and conditions of Contract signed between the District Project Officer, on behalf of State Project Director ISSE, Samagra Shiksha Itanagar and the appointee. The tenure of the service will be counted from the date of joining in the concern school.

The engagement is subject to the following conditions; -

- a. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b. No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and conditions in the agreement copy.
- c. During contract service period he/ she is not entitled for medical reimbursement, winter allowance. Children educational allowance, reimbursement of tuition fee. Leave travel concession LTC, special compensatory allowance etc.
- d. The contract teacher has to report his/ her duty at posting place within 7(seven) days from the date of appointment from the office of the DDSE cum DPO (ISSE), ICR, failing with his/her engagement order will automatically be treated as cancelled.
- e. He/ she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- f. The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of Literacy of Arunachal Pradesh addition to his/her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/ she will have to undergo DIET training at concern DIET for training as and when call.
- i. The other terms and condition of service which are not specified shall be governed by the relevant rules and order in force from time to time.
- j. The engaged incumbent has to sign an agreement for contract engagement before receiving this engagement order.
