ORDER

Shri Tame Kamak is hereby appointed as A/T on contract basis in the fixed pay of Rs. 7,200/- (Rupees Seven Thousands Two Hundreds) only with effect from the date of joining in the concerned School up to 31/03/2011 against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. He is posted at newly established Govt. Pry. School, Rigo under Sagalee Circle. The posting place fixed on the recommendation of SSA District Mission, Yupia.

The engagement is made vice resignation/expire/ waiting panel/ not joined of Shri/ Smt., J/T / A/T (SSA) (Application in case of resultant vacancies).

The engagement is subject to the following conditions: -

- a) The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f) The engaged teacher is also to work as volunteer instructor for TLC Programme for the interest of the literacy in Arunachal Pradesh in addition his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/She will have under go DIET training at concerned DIET for training as and when call for.
- i) The validity of contract period is upto 31/03/2011 which may be extended by seeing the performance/ regularity of teacher as recommended by concern V.E.C.
- j) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
