The appointment is subject to the following conditions:-(2)

The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and (i) their seniority will be fixed as per the overall merit.

The appointment is purely on temporary and may be terminated at any time by giving 1(one) (ii) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.

The regularization of service shall be considered on completion of probationary period subject to satisfactory performant of duty in his/her initial place of posting. After joining duty, he / she will have to take an oath of allegiance of affirmation to the
