b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per

terms and conditions mentioned in the agreement copy.

During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.

The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order

will automatically be treated as cancelled.

e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.

1) No representation will be accepted for change of posting place.

g) He/She will have under go DIET training at concerned DIET for training as and when call for.

The validity of contract period is upto 31/03/2016 which may be extended by seeing the performance/ regularity of teacher as recommended by concern SMC.

The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.-
