ORDER

Shri Taka Tegar is hereby engaged as FRT on Contractual basis against Lt. Meeting Sonam post(s) on compassionate ground for a period of 1 (one) year w.e.f. 1st April 2019 to 31st March 2020 at the fixed pay of Rs.25834/- (Rupees twenty five thousand eight hundred and thirty four) only and is posted at Govt. Primary School Runkit Colony P. Sector, Itanagar under following terms and conditions:-

1. That, he shall execute an undertaking to complete the requisite qualification within 2 years from the date of issuance of this Order.
2. That, his contractual service shall be liable to get terminated on failure to submit his requisite qualification within the stipulated time period as referred to at Sl. No. 1 above.
3. That, he shall not seek legal assistance for taking action against him on failure to fulfill the terms and conditions referred above at Sl. No. 1 & 2.
4. The incumbent must sign a DEED OF AGREEMENT before receiving the order with state authority that he will abide by all terms and conditions as per contractual terms.
5. The contractual employee shall have no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
6. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
7. During contract service period he is not entitled to medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), Special compensatory allowances etc.
8. The contractual employee has to report his duties at the place of posting within 7 (seven) days failing which his employment order will automatically be treated as cancelled.
9. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
10. No representation will be accepted for change of posting place.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
12. The contract service shall be terminated by the Office of State Project Director, Samagra Shiksha Society / ISSE, on receipt of substantive complaint from the concerned DDSE/DC of the district.
