## ORDER

Shri Tashi Dondu Musobi, is hereby engaged as A/T on contractual basis against the resultant vacancy post of PAB 2009-10 under West Kameng District in the fixed pay of Rs. 10,800 (Rupees Ten Thousand Eight Hundred) only with effect from the date of joining at Govt. Pry. School Musaksing, upto academic session against centrally sponsored scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions:-

- a. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c. During contract service period he/she is not entitled for medical re-imbursement, winter allowance, children education allowance, re-imbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
- d. The second party shall be entitled for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, bridge course and any other departmental engagement.
- e. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f. He/She is not entitled to subscribed GPF or CGEIS or such other scheme during the period of contract services.
- g. The engaged teacher is also to work as volunteers instructor for TLC Programme for the interest literacy in Arunachal Pradesh in addition to his/her normal duties.
- h. No representation will be accepted for change of posting place.
- i. He/She will have to under gone DIET training at concerned DIET for training as and when call for.
- j. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
- k. The engaged teacher has to sign and agreement for contract engagement before receiving this engagement order.
