2. The Officer shall be on Probation for a period of 2(two) years with effect from the date of joining. His/Her continuation in Service beyond probation period of two years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one months notice. If he/she wants to resign may require to give one months notice or surrender one months salary.
- (b) After joining in the duty he/she shall have to take an oath of allegiance or affirmation to the Constitution of India in the prescribed form.
- (c) He/She will have to produce medical fitness certificate in prescribed form from an authorised medical Officer.
- (d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- (e) Departmental candidates will get benefits of higher Scale of Pay as soon as they join their posting places.
