ORDER

Vide SPD, SSA, Itanagar appointment order No. AR/SSA/ESTT-1/13 Dated Itanagar the 3rd October, 2013 Shri. Mondeep Mondal, is hereby engaged as Junior Teacher on contract basis in the fixed pay of Rs. 26,453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only with effect from the date of joining in the concerned school upto 31" March 2014, against the centrally sponsored scheme of Sarva Shiksha Abhiyan.

He is posted at Govt. Middle School Bohn, under Kalaktang Circle.

The engagement is subject to the following conditions:

- a. The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period he/ she is not entitled for Medical Reimbursement; Winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- d. The contract employee is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- e. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f. No representation will be accepted for change of posting place.
- He/She will undergo DIET training at DIET Dirang as and when called for.
- h. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
