ORDER

Vide SPD, SSA, Itanagar appointment order No. AR/SSA/ESTT-1/13 Dated Itanagar the 3<sup>rd</sup> October, 2013 Shri. Mondeep Mondal, is hereby engaged as Junior Teacher on contract basis in the fixed pay of Rs. 26,453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only with effect from the date of joining in the concerned school upto 31<sup>st</sup> March 2014, against the centrally sponsored scheme of Sarva Shiksha Abhiyan.

He is posted at Govt. Middle School Boha, under Kalaktang Circle.

The engagement is subject to the following conditions:

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/ she is not entitled for Medical Reimbursement; Winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- The contract employee is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- No representation will be accepted for change of posting place.
- He/She will undergo DIET training at DIET Dirang as and when called for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
