Salary will be drawn only after receiving intimation from the head of the institution.
- ff) He she is not entitled to subscribe GPL or CGEIS or such other schemes during the period of contract services
- gg) The engaged teacher is also to work as volunteer instructor for 11 C. Programme for the interest of literacy in Arunachal Pradesh in addition tohis, her normal duties.
- hh) No representation will be accepted for change of posting place
- ii) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- ii) The selected teacher has to sign "Deed of Agreement" for contract appointment before receiving this appointment order
