ORDER

Shri Dorjee Khandu Thungon is hereby engaged as J/T on contract basis in the fixed pay of Rs. 8500/- (Rupees eight thousand and five hundred) only, with effect from the date of joining in the concerned District against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is posted at Gorbau U/Pry School, West Kameng District.

The engagement is made on special compensatory ground against the resultant vacancy tendered resignation by Ms. Pema Thungon, J/T.

The engagement is subject to the following conditions:-

- a. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b. No earned leave is permissible except casual leave as per Central Civil Service Rules and as per terms and conditions mentioned in the agreement copy.
- c. During contract service he is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession(LTC); special compensatory allowances etc.
- d. The Second party shall be entitled for drawal of salary of the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e. The contract teacher have to report his duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE, failing which his engagement order will be automatically be trated cancelled.
- f. He is not entitled to GPF or CGEIS or such other schemes during the period of contract services.
- g. The engaged teacher is also to work as volunteeer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his normal duty.
- h. No representation will be accepted for change of posting place.
- i. He will have to under go DIET training at the concern DIET for training as and when call for.
- j. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- k. The engaged has to sign an agreement for contract engagement before receiving this engagement order.
