The officer shall be on probation for a period of 2 (two) years with effect from the date joining his/her continuation in services beyond probation period of two years is Subject to satisfactory performance during probation period.

The appointment is Subject to the following Conditions:-



(a) The appointment is purely temporary and may be terminated at any time without assigning any reason after serving one Month's notice. If he/she wants to resign may be required to give one Month's notice or surrender one Month salary.

(b) After Joining in the duty he/she shall have to take oath of allegiance of affirmation to the Constitutions of India in the prescribed form.

(c) He/she have to produce medical fitness Certificate in prescribed form from a authorised medical officer.

(d) The appointant is subject to police Verification and he/she will be dismissed from Govt. service if any adverse reports are here with immediate effect.

The other terms and conditions of service which are not specified here in shall be governed by the relevant rules and order in-force from time to time.

He/she will be transferred to schools any where in Arunachal Pradesh. No application will be entertained for changing of posting places.
