**ORDER**

In pursuance of Govt. approval vide U.O. No. Nil dated 3/3/2005, the service of Miss Yaru Yoka is hereby regularized temporarily to officiate as Assistant Teacher(A) in the scale of pay of Rs.4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from he/she actually reports for duty to the DDSE, Yupia, Papum Pare District, Arunachal Pradesh. - c) After joining he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if any adverse report is there with immediate effect.
