In pursuance of Govt. approval vide U.O.No.20 Dated 17.05.2007, Smti Kenpi Nyorak is hereby regularized temporarily to officiate as Junior Teacher (Language) in the scale of pay of Rs: 5500-175-9000/- p.m. plus other allowances as admissible under rules from time to time with effect from 01.05.2007. He/She is appointed against Shri Yogeshwar Rai, JT (Retired) and is posted under the disposal of DDSE, Yupia, Papum Pare District, Arunachal Pradesh.

2. The appointee shall be on probation for a period of 2(two) years with effect from the date of joining. His/Her continuation in services beyond probation period of 2(two) years is subject to satisfactory performance during probation period.
3. **The appointment is subject to the following conditions:-**
 - (a) The appointment is purely temporary and may be terminated with 1(one) month notice. If he/she want to resign she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
 - (b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
 - (c) After joining duty he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
 - (d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
 - (e) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if there is any adverse report from the police.


