- The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering (iii)
- The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- He / she will have to produce Medical Fitness Certificate from an authorized (v)

### Terms and conditions:-

- h) He or She shall strictly abide by all the Terms and Conditions governing his/her appointment.
- i) His or Her period of probation shall be 3(three) years from the date of joining in service.
- j) He or She shall undertake to spend the initial 5(five) years of service including 3 years of probation period in hard and remote area where he or she gets posted at the time of appointment or in hard and remote area where he or she is transferred by the Govt. in the initial 5 years.
- k) He or She will not represent for his/her transfer/posting out of hard and remote area in initial 5 years of service. If he or she do not abide by this condition his/her services shall stand terminated immediately.
- l) He or She will not seek political intervention in matters related to his/her service such as transfer/posting etc.
- m) He or she shall report for duty within one month from the date of issue of appointment order, failing which it will be presumed that he or she is not willing to join the post and accordingly his/her appointment order shall stand cancelled.
- n) His or Her appointment may be terminated at any time by giving one month's notice given by either side viz. his/her, or appointing authority without assigning any reasons. The appointing authority shall however reserve the right to terminate his/her service forthwith or before the notice by making payment of a sum equivalent to the pay and allowances for the period of notice or the expired portion thereof.

- h) Since private practice of any kind including laboratory and consultant practice are prohibited as per section 13 of APHS Rules 2000 hence he or she shall not carry out such activities during his or her period of service. If he or she do not abide by this condition his/her services shall stand terminated immediately.
- i) No TA/DA will be allowed while joining for first appointment.
- j) The service seniority shall be counted as per merit list provided by APPSC.
- k) If any declaration given or information furnished by him or her proves to be false or if he or she is found to have willfully suppressed any material or information he or she shall be liable for removal from service and such other action as government deems fit and proper.
- l) He or She must follow good conduct and appropriate behaviour at all times.
