**ORDER**

In pursuance of Govt. approval vide U.O. No. 230 dated 04/06/2015 Sri. Badalam Tarainyu is hereby regularized temporarily as Primary Teacher (Assistant Teacher-A) in the pay scale of PB.2-9300 34800+ GP-4200/- per month plus other allowances as admissible under rules from time to time with effect of the date he/she reports for duty at Govt. Primary School, Bhasw under DDSE, Hawaii, Anjaw District.

The regularization is made against the resultant vacancy of Sri. Ratam Dey, Primary Teacher, retired.

The regularization shall be on probation for a period of 2 (two) years w.e.f. the date of joining his/her continuation beyond probation period for 2 (two) year shall be subjected to satisfactory performance during probation period.

**The regularization is Subjected to the following condition:-**

1. The regularization is purely and temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he/she may do so after giving on month notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
3. After joining duty he/she will have to produce medical fitness certificate form an authorized Medical Officer.
4. The regularization is subjected to police verification and he/she will be dismissed from service if any adverse report is fund against him/ her with immediate effect.
5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining the appointee shall have to serve for s minimum period of 3(three) years at the place of posting.
7. The regularization order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15(Fifteen) days from the date of issue of this order at posting place.
8. On their regularization as Primary Teacher (AT-A) they should undergo compulsory in service DPE/D.El.Ed/ B. Ed. within 3 (three) years failing which their regularization order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
