OFFER LETTER

The Governor of Arunachal Pradesh is pleased to offer **Nyanu Doji** a post of Assistant Engineer (Electrical) in the Department of Power, Govt. of Arunachal Pradesh on the basis of recommendation made by the Arunachal Pradesh Public Service Commission in the pay band PB-3 Rs. 15600-39100 + GP 5400 plus other allowances as admissible from time to time subjects to the following terms and conditions:-

1. Furnishing of Police Verification attestation form in duplicate. Formal appointment order shall be issued upon receipt of satisfactory police verification report from the concerned authority, as stipulated in O M No.AR-142/2010 dated 27/10/2010. The appointment in the post of AE (E) and continuance thereon further shall be subject to positive outcome of Police Verification.
2. The appointment will be governed by the relevant rules and order of the Government as are issued from time to time.
3. The appointment carries the liability to serve in any part of Arunachal Pradesh or outside where the Department of Power has an organization in the interest of public service. However, in the exigency of service he shall be liable to serve in any organization, as may be decided upon by the state govt. in the interest of public service.
4. Taking of Oath of Allegiance to the Constitution of India and also an oath under the official secrets Act at the time of taking upon appointment.
5. Furnishing full details of movable and immovable properties/assets in his or spouse name within four weeks from the date of joining.
6. Furnishing certificate in the prescribed format, in support of his claim to be a scheduled Tribe of Arunachal Pradesh, in case he is a Schedule Tribe of Arunachal Pradesh.
7. Production of certificate of fitness from a Medical Board. However, a certificate from civil surgeon/District Medical Officer will be accepted provisionally.
8. Production of the following certificate in original :-
 - (a) Educational and other certification.
 - (b) Certificate in support of age.
 - (c) Character certificate from District or Sub-Divisional Magistrate or from two Gazetted Officers known to him for the last three years prior to this appointment.
9. He should not have more than one spouse, at any time, through out his service tenure.
10. If he is in service, then he should submit his release order from his former employer along with his acceptance.
11. On appointment to the post of Assistant Engineer (E) he should serve two year's tenure in planning section.
12. No TA/DA will be allowed for joining the post offered/place of posting. If the offer of appointment is not accepted formally within 15(fifteen) days from the date of this offer, the offer of appointment shall stand cancelled automatically.
13. The appointee shall be on probation for a period of 2(two) Years.
