ORDER

Sri/Smtl/Miss. Antoshi Pul (Kri) is hereby engaged as Assistant Teacher on contract basis up to 31.03.2007 in the fixed pay of Rs.7200/- (Rs. Seven Thousand Two Hundred) only with effect from the date of joining in the Govt. P.ry. School, Mekaliang against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions

- The contract teacher has no right to claim for regular appointment /regularization of the post after expiry of contract period.
- No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances and any other such allowances.
- He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/ her normal duties.
- No representation will be accepted for change of posting place.
- He/she will have to under gone DIET training at concerned DIET for training as and when called for.
- The other terms and conditions of services which are not specified shall be governed by the Relevant rules /Orders / Guide lines / Instruction in force time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- His/Her contractual service will remain valid only up to 31.03.07 and thereafter it will be treated automatically terminated and a fresh renewal would be required.
- He / She will have to report for duty at his / her posting place positively on 01.6.06. failing which his/her engagement order will automatically be treated as cancelled. His / her Pay will be drawn only after getting joining report through the concerned A P O (AE) / A D E O.

The appointee shall be on probation for a period of 2 (two) years with effect from the date of issue of order. His/Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

This issued with the Approval of Govt. Vide Note No. #139 Dated 19-07-2022.

The Appointment is subject to the following conditions:-

1. The salary will be drawn from the date of his/her joining in the duty.
2. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
3. The regularization of service will be considered on completion of probation period subject to satisfactory performance of duty.
4. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
5. The appointment is subject to Police verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
6. After joining duty he/she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
7. On joining, the appointee shall have to serve for a minimum period of 3 (Three) years at the place of posting.
8. The seniority of the appointee shall be based strictly on their date of joining.
9. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at his/her posting place and copy of joining report be submitted to this Directorate through DDSE concerned.
10. On their appointment as Primary Teacher (PRT) they should undergo compulsory in-service course of DPE/D.El.Ed within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the rules in force from time to time.


