

O R D E R

Sri Ongla Gojo Singpho is hereby appointed as A.M.T. Teacher (in contract) by order No. 108102/ (Rupee Ten thousand eight hundred) only with effect from the date of joining against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He is posted at Govt. P.S. Naladiquah under Vijaynagar Circle.

The appointment is subject to the following conditions

1. The contract teacher has no right to claim for regular appointment/regularization of the job after expiry of contract appointment.
2. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rules and terms and condition mentioned in the agreement copy.
3. During contract services period he is not entitle for medical reimbursement, winter allowance, children educational allowances, reimbursement of tuition fees, leave travel concession etc. special compensatory allowances etc.
4. The Second Party shall be entitled for drawal salary of only for the academic session. Salary for vacation period shall be drawn only when they are engaged in training, bridge course and other department engagement.
5. The contract teacher have to report his duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which her engagement order will be automatically treated as cancelled.
6. He is not entitle to subscribed GPF or CGIS or other schemes during the period of contract services.
7. The appointed teacher is also to work as volunteer instra for for TLC programme for the welfare of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. No representation will be accepted for changing of posting place.
9. He will have to under gone DIET training at DIET Changlang for training as and when called.
10. The other terms and conditions of services which are not specified shall be governed by relevant rules and orders in forced time to time.
11. The appointed teacher has to sign an agreement for contract before receiving this engagement order.
