h) No representation will be accepted for changing of posting place.

i) He/She will have to under gone DIET training at DIET Changlang for training as and when call for.

j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.

k) The appointed teacher has to sign an agreement for contract before receiving this engagement order.
