**ORDER.**

Miss Luja Singpho, is hereby appointed as Assistant Teacher on contract basis in the fixed pay of Rs 7200/- (rupees Seven thousand two hundred) only per month with effect from date of joining in the concern school against Centrally Sponsored Scheme of **Sarva Shiksha Abhiyan** and posted at Govt. Pry. School Wagon II

The appointment is made vice Sri Onggam Singpho, A/T SSA resigned.

The appointment is subject to the following conditions :-

- a) The contract appointee has no right to claim for regular appointment /regularization of the post after expiry of contract appointment.
- b) No earned leave /Maternity leave /paternity leave is admissible except casual leave as per Central Civil service leave rule as per terms and condition in the agreement copy.
- c) During contract services period he/she is not entitle for medical reimbursement ,winter allowances, children educational allowances ,reimbursement of tuition fees, leave travel concession(LTC) ,special compensatory allowances etc
- d) The appointee have to report his /her duty at posting place within 7(seven) days from the date of appointment failing which his/her appointment will be automatically be treated as cancelled.
- e) He/she is not entitle to subscribe GPF or CGEIS or such other scheme during the period of contract services.
- f) The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his normal duties.
- g) No representation will be accepted for changing of posting place.
- h) He/she will have to under go DIET training at Changlang .
- i) The terms and conditions of services which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
- j) The appointee teacher has to sign an agreement for contract appointment before receiving this appointment order.
