- e) During contract services period he/she is not entitle for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- d) The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other department engagement.
